Minutes of meeting held on 10 September 2024, 7pm, at Bossingham Village Hall

1. Attendance and apologies for absence

4. Public participation on Agenda items

John Pitcher has cared for the village hall and war memorial gardens for nearly 10 years and is happy to carry on for now, although help will be needed in future. The shrubs he has planted to take the pressure off annual planting are developing well, and the daffodil and dahlia bulbs will still come through.

John has been the parish Tree Officer for 10 years and will stand down in November. Councillors thanked John for all his work as tree officer, especially in instigating the tree survey in 2020 which highlighted trees next to the car park which needed attention, and for his continued gardening. The Tree Officer role will be advertised in the October parish magazine.

Despite the address being supplied over 12 months ago, planners claimed difficulties in tracking down site owner and are currently investigating if a business is being run on the land without planning permission. The Forestry Commission is checking if there has been a breach of any felling licenses on that land.

 - 11.1 h When it is to enter into a contract of less than £25,000 in value for the supply of goods or materials or for the execution of works or specialist services other than such goods, materials, works or specialist services as are excepted as set out in paragraph (a) the Clerk or RFO shall obtain 3 quotations (priced descriptions of the proposed supply); where the value is below £3,000 and above £100 the Clerk or RFO shall strive to obtain 3 estimates.

12. Highways Improvement Plan (HIP)

Cllr Simon Warner has been advised by Annaliese Mortlock at CCC that the 30mph road marking roundel will be added at the north end of the village in the near future.

No further progress with village gateway sign and other HIP items since the last meeting. CCC is aware we have funds for village gateway sign provision.

(HIP proposals include:

- to install a village gateway sign at the north end of Bossingham village where the 30mph sign is not always visible
- to repaint the 30mph roundel on the road at the southern end of Bossingham
- to install clear 'no oversize vehicles' warning signs at both ends of Lime Kiln Lane.)

13. Waste bin

- 13.1 Following parishioner concerns raised at the last meeting re. dog poo on the footpaths, an article was included in the September issue of Hardres & Stelling News highlighting its dangers to humans and animals and the law on not picking up after your pet.
- 13.2 Signage and other actions

Cllr Mike Bland informs us that CCC's enforcement team can do some or all of the following:

- a. Clean up the footpaths identified as far as the district council boundary with Folkestone. (for the footpaths near the Scout Hut it is recommended to ask F&HDC to clean up the footpath on their side of the boundary)
- b. Provide signage warning that dog fouling is an offence.
- c. Provide an occasional uniformed patrol, once the signage is up.

14. Website

Our website host, HugoFox, has today launched information about providing .gov.uk domains and as a Bronze customer this new domain will be free. As no timings for this service have yet been released, it was resolved to renew the current domain name for now (due in Oct).

HugoFox will charge for any .gov.uk email addresses, no cost details yet released.

Clerk has registered with the government's Department for Science, Innovation & Technology 'Parish Council Domains Helper Service' and will attend an online session to find out more.

6.7 Long-term outstanding planning applications affected by water quality at Stodmarsh nature reserve:

Poor water quality levels at the internationally-important nature reserve in Stodmarsh have stalled housing developments across east Kent. The wetlands at Stodmarsh outside Canterbury, which are a haven for wildlife, are deemed to be suffering from high levels of nitrogen and phosphorous. Further information can be found here:

Awaiting CCC decision Erection of a dwelling and garage in rear garden together with alterations to existing dwelling including new single storey side extension following demolition of garage and chimney to enable formation of access
- c. CA/20/02237 Two Acres, Hardres Court Road CT4 6EA Acceptable. Awaiting CCC decision Erection of 5 no. detached two-storey dwellings with associated garages, parking and landscaping following demolition of existing dwelling.

8.1 County Councillor Mike Sole – August 2024

This month I caught up with KCC on the progress of highway improvements across the parishes. Where there are parish councils, they are usually the starting point for improvements. KCC then look at what can be done within both financial and legal restraints. I am often able to help get these projects over the line with grant support. Just a few of the improvements in the pipeline are:

Ickham - additional SLOW markings near Cherville Lane and work on the Drill Lane ford

Littlebourne - 20mph limits along Jubilee Road, Church Lane, Nargate Street and part of

Bekesbourne Lane

Patrixbourne – 20mph limit and village gateway

Upper Hardres - HGV signage and subject to agreement on location, village gateway

Barham – 20mph limits in parts of village and outside school

Womenswold - 30mph limit in Woolage Green

Thanington – 30mph limit repeaters in New House Lane

Waltham - village gateway

Bridge - HGV signage in Union Road and works to slow traffic on Bridge Hill

Long overdue changes to bin collection rounds this summer, resulted in significantly more problems than anticipated. Many bins were missed as crews got used to new rounds. Things were worst in the rural areas and where there are communal bins, but once settled in the new rounds will be more efficient. Thankfully we did not experience any significant trouble earlier in the month, like we saw in other parts of the country. With fellow councillors I visited the Canterbury mosque to show support during that worrying time.

This month I have been assisting residents with housing issues, bins, council tax, parish council funding, anti-social behaviour and potholes.

Following on from the successful joint surgery with Bridge Parish Council, another one is being organised for late September.

8.3 Tree officer John Pitcher

Regarding the Tree Warden role for the Parish, I complete ten years in the role on the 12 November and feel it's time for a change with someone a little younger with fresh ideas taking over. I have registered to attend a day seminar hosted by The Kent Tree and Pond Partnership and with National speakers from the Woodland Trust on Saturday, the 14 September relating to urban tree and hedge plantings as well as other relevant issues. I will of course be happy to pass on any useful information to the new incumbent.

The tree diseases are a constant issue across the land as are pest invasions which constantly cause concern to various species. Despite all this, tree canopies are still looking good and with autumn just around the corner, the beauty of colour is always so apparent and delightful.

The oak tree in the centre of the village still looks a little 'weak' but time will tell and so far, no further evidence of honey fungus around it.
