# Minutes of meeting held on Tuesday 15 November 2022, 7pm, at Bossingham Village Hall

## 1. Attendance and apologies for absence

- 2. It was resolved unanimously to accept the Minutes of the meeting held on 04.10.22.

- 6.1 CA/22/01870 Land At The Street, Bossingham ` Comments to CCC by 02 December 2022 Variation of condition 2 (drawings) of planning permission CA/19/01902/FUL for the Proposed erection of 4 no. detached two-storey dwellings together with double garages and new vehicular access to The Street, Bossingham; to allow plot 1 garage location adjusted, plot 1 obscure glass retained to elevation 3, obscure glazing removed to elevation 4, plot 3 obscure glass retained to elevation 3 and obscure glazing removed to elevation 4.
- 6.2 CA/22/01748 Knotty Oak, The Street, Bossingham CT4 6DX UHPC Neutral. Awaiting CCC decision First floor extension

Comment to CCC: UHPC requests that consideration is given to the privacy of neighbours' gardens either side of 'Knotty Oak' and the potential for loss of daylight to the neighbours' properties.

## Other planning matters:

- 6.3 Applications affected by poor water quality levels at Stodmarsh nature reserve are listed in the Appendix.
- 6.4 ENF/22/00024 Land at Lime Kiln Lane: A councillor met with KCC Cllr Mike Sole and visited the location. Mike was very helpful and has said he will raise the matter with the member with responsibility for enforcement and that CCC will write to the landowner in order to arrange to gain access to inspect. It will be beneficial to regularly contact planning for an update. Councillors thanked Mike for his assistance.
- 6.5 CA/19/01902 Land at The Street, Bossingham: Following a parishioner query re. building height, CCC Planning Dept confirmed that the decision on this application was made by the Planning Committee and the building height complies with the relevant design and landscape policies in the Local Plan. Decision documents with full details can be found on the CCC website.

The hedge on the village hall car park boundary will be allowed to grow slightly higher to obscure the development.

# 7. Highways

Parishioners may report Highways matters directly to KCC here

7.1 Temporary Road Closure: Manns Hill, Bossingham: 31st October 2022 with estimated completion by 24th November 2022. For electrical connection works by UK Power Networks.
 Cllrs reported they found the workforce to be helpful and accommodating, despite complaints from some residents. The road closure and diversion were necessary due to the road width, and councillors consider sufficient notice was given by UKPN/KCC of the closure. Cllr Nick Waldron will email UKPN to thank them for

their dealings with complaints from some residents.

It is hoped SE Water will fit in remedial works at the end of the UKPN works to prevent another road closure at a later date.

This UKPN work carried out on Manns Hill is to connect a high voltage supply from the substation by the scout hut to a new substation. As a result, if power is cut in future, it can be reinstated faster and the supply will be more robust. Originally a 50KVA transformer, a 515KVA transformer is being installed. This will provide a much better supply to meet future increased electricity demands for eg. EV charging points, electric heating. It was resolved to continue to use current methods of communication with residents with regard to communications about road closures, ie. Email List, website, parish magazine, Facebook.

- 7.2 Report Ref. 657922 Church Lane to junction with Stone Street: carriageway dip/depression/defect. Chairman to follow up
- 7.3 Stone Street speed reduction: A request was received from Petham Parish Council for a contribution to their approx. £5,200 cost of implementing the new 40mph speed limit on Stone Street between Thompsons Garden Centre and Hogg Lane which borders Petham and UH Parish Councils. **It was resolved** to contribute £500.
- 7.4 Flooding on The Street: Parishioners are encouraged to report to Highways whenever there is a flood as a high number of reports are needed to ensure action will be taken.

  Further flooding on The Street was reported to the Chairman. When KCC investigated their cameras showed the drains were clear and they recommend reporting flooding regularly so they can programme gulley-suck maintenance to be carried out to aid drainage. A water leak on Catts Wood Path has been sealed and there is a possibility this may be causing back-up flooding issues on The Street. Chairman to enquire.

  Flooding during heavy rains on Hardres Court Road: (corner by the Manor House) will subside into the soak away which, at this time of year, is blocked by leaves and may take longer to drain.
- 7.5 Cllr Mike Sole recommends a parish Highways Improvement Plan (HIP) is compiled to prioritise works to roads in the parish. To include on January's Agenda.
- 7.6 A Stopping Up Order can be applied for to change ownership of rights of a road surface by KCC to a resident. If a resident applies for a Stopping Up Order, the parish council will be informed.

## 8.2 **Footpaths**

Councillors thank Rob Veltman for his letter and kind donation.

- a. New footpath warden: Councillors welcomed Linda Warner as the new parish footpath warden. Linda has been in touch with Rob Veltman and has received information on the parish's paths.
- b. Public Footpath CB378 opposite Village Hall: signage to be produced by the parish council. Cllr Nick Waldron and the clerk to arrange. Stile has collapsed and needs replacing.
- c. Public Footpath TR157472: missing sign, Atchester Wood, footpath warden to investigate.
- d. Maura Pell was recently appointed Ramblers Sector Co-ordinator, Canterbury South, as well as Local Footpath Officer for Canterbury South, an area which includes Upper Hardres.
- e. U11610 Catt's Wood Lane Path: Parishioner request for this track to be made suitable for horse riding, footpath warden to investigate and reply.
- f. Parishioner request for maximum vehicle weight signage to be installed at Stone St end of Lime Kiln Lane: There is a sign in situ but it is obscured by foliage. Chairman will report. To investigate if clearer signage would be more appropriate, eg. Unsuitable for HGV or Max width/Max weight limit sign and include in a Highways Improvement Plan (HIP).

# 8.3 Tree Warden

- a. It was resolved to provide £100 in January 2023 and £100 in January 2024 towards planting at the VH flower bed and war memorial. John Pitcher had kindly offered to donate plants but councillors feel it only fair to contribute, especially as John is changing the planting scheme to include more perennials and small shrubs for lower maintenance.
- b. Parishioner query received re. work to trees affected by ash die back: Chairman to check progress with landowner.

Crown raising and thinning of trees in the toddler climber/slide corner is being investigated. Permission from CCC for Works to Trees will be applied for.

**It was resolved** unanimously to approve expenditure, proposed by Cllr Nick Waldron, seconded by Cllr Angela Waldron, approved by the Chairman.

9.5 A draft Budget 2023/24 was circulated to councillors for consideration prior to the meeting. Increases include election 2023 fees, defibrillator annual service contract, clerk's salary increase and External Audit requirement. Other necessary increases are kept to a minimum.

It was resolved to accept the Budget and to apply to CCC for a Precept of £6,566.00 for 2023/24.

9.6 The Barclays Security Review has been delayed whilst consideration is given to moving to a Santander Deposit account in order to streamline online banking.

£15,147.00 received on 25.10.22. This is the first of two payments, second payment due April 2023. **It was resolved** to invite Bossingham Village Hall Management Committee to submit requests for village hall improvements to be funded from CIL funds.

# 15. Defibrillator

Due to its urgent nature, councillors' approval was given by email to the clerk to appoint Hopkins Training

- & Support to service and maintain the defibrillator and their AED Aftercare Plan is now in place.
  - Hopkins Training and Support: <a href="https://trainingandsupport.co.uk/">https://trainingandsupport.co.uk/</a> AED Aftercare Plan £189.00+vat per annum (includes 4 site visits a year for checks, 3hr training session), parts extra.

Hopkins found the defib should have been recalled by the manufacturer due to a fault with the battery life light. They swiftly arranged for it to be returned to the manufacturer, put a loan device in its place, and replaced it once it had been upgraded and fitted with a new battery.

They have registered the defib with SECAmb's The Circuit. From SECAmb's website:

'The defibrillators in our region are registered on <u>The Circuit</u> – a national defibrillator network that is supported by the British Heart Foundation, St John Ambulance, Resuscitation Council UK and the Association of Ambulance Chief Executives. The Circuit will ensure that we can continue to direct members of the public to your defibrillator.'

Hopkins will carry out checks on a three-monthly basis as part of their AED Aftercare Plan. A councillor to check the device monthly.

The Clerk and Councillors thank Hopkins Training & Support for their expert and attentive service, ensuring the Upper Hardres defibrillator is ready for service if ever needed.

Alternative quotations for servicing were requested from:

- Turtle Engineering: (original supplier) No response.
- Save a Life: defibshop.co.uk one-off service only, £165.00+vat, parts extra.

**It was resolved** to canvas parishioners for their interest in attending a 3hr training session by Hopkins (included in their Aftercare Plan) in spring/summer at the Village Hall.

**It was resolved** to accept Wraight's quotation to carry out a one-off grounds maintenance session at the scout hut. Cllr Nick Waldron will liaise with the scout leader.

# **County Councillor Mike Sole**

November 2022 (an update on what I have been doing in October)

The draft Canterbury City Council Local Plan went out for consultation this month. You can take part at by searching "Canterbury Local Plan Consultation 2045" online. The consultation closes at 5pm on 16 January 2023.

The Local Plan is quite controversial in places, including traffic zoning in and around the city, and a large number are large housing developments in Thanington, Littlebourne, Womenswold and most significantly a new town at Adisham. I spoke at the CCC cabinet meeting to try to get Adisham new town removed - it is not believed to be deliverable as the owners of the majority of the land do not wish to see it developed. Since then I have attended the Adisham Parish Council planning sub-committee and chaired a meeting of affected parishes in the Canterbury and Dover area, which included Womenswold, Adisham, Bekesbourne with Patrixbourne, Littlebourne, Aylesham and Wingham. Together these parishes will be opposing the proposed developments in Adisham and Womenswold parishes. My views have been included on BBC Radio Kent and featured in the Kentish Gazette.

At Kent County Council, I seconded and spoke on a motion, that was passed by the council, to condemn the actions of Southern Water and to work to improve our water quality and stop the dumping of sewerage in our rivers and sea. I also raised questions about the lack of capacity on school time buses, and I continue to follow this up.

I was delighted to be asked to speak on KCC issues at the Hilltop Community Association AGM (New House Lane, Thanington) and also to hear of the parish council's concerns about the draft local plan.

The Wincheap gyratory scheme (new one-way system along Wincheap and the industrial estate) has again reared its ugly head with developers announcing that work will start on it early next year. This was approved by Canterbury City Council (CCC) around five years ago, hidden away in the planning application for the homes currently being built in Cockering Lane. I am working with other councillors, residents and businesses to raise concerns, but at present KCC are adamant that as it has been approved it will go ahead as it was approved by CCC.

I have now been appointed to the Kent & Medway Fire and Rescue Authority and attended my first meeting this month. I also attended a meeting of the River Stour Internal Drainage Board.

I am delighted that we are making progress with a 30mph limit in Woolage Village. I started campaigning for this ten years

ago, so it is especially satisfying to be able to help bring it to fruition since becoming a county councillor. The reduction in speed limit on Petham Stone Street from 50mph to 40mph is also progressing.

I have also attended Canterbury City Council full meeting, although under the cabinet system these are not as interesting as they once were as most decisions have already been made by Cabinet.

In Stodmarsh I'm pleased to have agreed a drainage solution with the KCC team to hopeful stop the huge puddles appearing and this work should be carried out before Christmas.

This month I have spent time walking around Woolage Village and Bridge, knocking on doors and discussing various issues with residents that I am now following up with KCC and Canterbury City Council.

## 8.3 Bossingham Village Hall Gabby Fisher, Secretary

The improvement works continue and hopefully will be completed this year. The PAT testing has been completed and the Fire Extinguisher inspection is happening on 21st November. KCC have stopped The Inspection Services from 2nd December 2022, so a new provider will need to be found to carry out the annual inspection next year.

The lockable storage box for the gardening equipment is in situ. Thank you to UHPC for covering the cost of this.

The Committee did not apply for the CCC Grant this year but will look to do so next time.

The next Village Hall Committee meeting is on 22nd November 2022, and we will report back in more detail at the Parish Council Meeting in the New Year.

As we approach the end of 2022, I would like to thank the Parish Council on behalf of the Village Hall Committee for their on-going support and look forward to continuing to work together in 2023.
