# Minutes of meeting held on Tuesday 12 July 2022, 7pm, at Bossingham Village Hall

## 1a. Co-option of new councillor

A Notice of Vacancy was published on 11 May. On 1 June Canterbury City Council informed us that as they had not received a request to hold a by-election to fill the vacancy, the parish council may co-opt to fill the vacancy. Two applications were received, one applicant has since stood down. The remaining applicant, Simon Warner, spoke to councillors to outline what he would bring to the role and councillors agreed unanimously to invite Simon to join the council.

Simon Warner signed the Declaration of Acceptance of Office form and will complete the Disclosure of Personal Interests form.

# a. Refuse collection:

A parishioner highlighted that paper and recycling is not being collected properly, inserts are not replaced, and waste is regularly left strewn across parish roads. The Chairman raised this with Andrew Cook, the CCC Cabinet Member for Environmental Services. Andrew was understanding and supportive and recommends the following course of action if parishioners have any of the following issues:

- 1. Bin collections missed
- 2. Rubbish dropped on the ground after the bins have been emptied into the compactor
- 3. Bins not returned to the point they were left out/collected from.

#### b. Japanese Knotweed and Ash dieback:

On CB376, at rear of Forge House adjacent to Stars, a parishioner report of Japanese Knotweed and ash dieback was reported to KCC/CCC by Rob Veltman who also queried the footpath line with KCC/PRoW as it has gained considerable width in parts. Rob reported fly-tipping on this path (FLT006334), since collected Action: knotweed is being sprayed and monitored monthly; fly-tipping was reported to CCC and collected promptly; line of path is being investigated by footpath warden (see report)

- 6.10 Development at The Street: Issues with adherence to plans have been raised with CCC Planning Dept. Issues with dust are also being raised. Complaints received re. Jubilee Bank Holiday working in possible contravention of planning conditions were reported to enforcement officer at CCC
- 6.11 ENF/22/00024 Land at Lime Kiln Lane: No planning application has been received and extensive works at this site have been queried with CCC this year. Cllr Nick Waldron to contact enforcement officer.

## 7. Highways

- a. Road Repairs: Numerous pothole repairs on Manns Hill reported to KCC have now been completed
- b. Verge obstructions on The Street: Chairman has requested Parish Highways Steward to check safety
- c. Flooding on The Street: Broken pipe is believed to be causing the problem, reported in 2019 and pipe cleaned in 2021. Reports to the KCC Highways portal under 'Drainage and Flooding' are needed by parishioners to prioritise further KCC investigation. If parishioners are unable to use the portal, please email the parish council to report on your behalf.
- d. Road closure: Part of Bursted Hill, Bishopsbourne, at junction with Pett Bottom Road, 29 July for one day for drainage works by KCC
- e. Highways Fault No. 636258: Temporary signage left in place for the last 12 months+ re. road resurfacing works on the boundary of the village hall now removed
- f. Stone Street speed reduction: to request update from Petham PC
- g. Lime Kiln Lane: 'Unsuitable for long or heavy goods vehicle' sign now replaced. A parishioner queried the suitability of the National Speed limit (understood to be 60mph) on this narrow lane and information of the variability of the national speed limit according to road conditions will be passed on
- h. Motorsport UK Competition: (permit no. 28647JY17) route using U11610 Catts Wood Path on 17 July

- queried with Highways Steward on 11 July and passed to relevant department for investigation
- i. Stone Street closed overnight 8pm-5am 18-24 July inclusive: Parish council not notified as these works are being carried out by the Road Assets Team, a division of KCC Highways. The planned resurfacing works involve 100mm deep patching to provide long-lasting repairs

- j. Water leaks:
  - i. Water leak Manns Hill report details -
    - Original fault No. 33952633, reported 16.06.22 Engineer unable to gain attendance to the leak New Fault No. 34657154, reported 07.07.22 South East Water advised they will escalate the fault; they say their main is on the opposite side to the leak and the problem may be on a customer's joint
  - ii. Water leak junction of Bursted Manor and Hardres Court Road report details:
    Fault No. 34477265, reported 11.06.22 South East Water update: The leak was investigated 07.07.22
    and found to be on a home owners supply pipe. Chairman was advised that a W4 letter will be sent to the land/home owner advising them of the issue and how it should be addressed within fourteen days of receiving the letter.

## 8. Reports

- 8.2 Footpath Warden: see Appendix
  - CB378 opposite Village Hall: The landowner finds the footpath isn't always respected with some walkers roaming onto crops and dog waste being left and spoiling some crops.

It was resolved for a councillor to keep dialogue open with the landowner and to draft a sign displaying the route of the path and requesting walkers' adherence to the path. The parish council has offered to replant the blocked gap in the hedge after harvest. Stile needs to be reinstated and Cllr Nick Waldron will source quotations. Longer term, material could be packed in to correct the area liable to flooding.

- 8.3 Tree Warden
  - It was resolved to reimburse tree and Platinum Jubilee plaque costs of £170 to John Pitcher, tree warden.
- 8.4 Bossingham Village Hall
  - Many thanks to Nikki Gordon and the VH committee for arranging the joint parish's Platinum Jubilee celebrations at Bossingham Village Hall on Sunday 5 June
  - Proof of spend of 2022/23 CCC Capital Grant for BVH patio was submitted to CCC on 19 May
  - BVHMC AGM Minutes received and circulated to councillors.
- 8.5 Neighbourhood Plan Steering Group
  - Steering Group membership has fallen and the future of the project has become uncertain. In September, to review what has been learnt so far and to decide the future of the group. Chairman recognised the time and effort spent by Cllr Mick Broughton which is much appreciated by the parish council.
- 8.6 Bossingham Playing Field
  - Maintenance highlighted in the 2021 annual inspection is complete, £434.40 of £500 assigned budget spent
  - Replacement small gate sign with site address, email address and what3words location received, to be fitted
  - Double gate access to playing field: padlock keyholders are Chairman and Wraight's Grounds maintenance. Cllr Nick Waldron to hang emergency spare key for double gate padlock in lobby next to defib.

It was resolved to develop a CIL Policy document (based on the Chestfield PC document) with a plan of time scales for spend, to be adopted at the next meeting.

# 13. Risk Assessment update

Bus shelter: Attend to repairs when CIL funds received

Defibrillator: Regular inspections being carried out and to be logged by Cllr Mick Broughton Fire Hydrants: Last KF&RS inspection of UH hydrants was December 2021. A visual inspection of UH hydrants carried out by Simon Warner on 03.06.22 highlighted many faults which the clerk has reported to KF&RS. Clerk to chase up maintenance with KF&RS.

# 6. Planning

6.1 CA/22/01211 Oakgate House, Manns Hill, Bossingham CT4 6EB

The application Should be Refused - due to accessibility, traffic, roads and being a designated passing point. The Parish Council also supports the responses filed to CCC by two parishioners

6.2 CA/22/00443 Plot 11 Little Jacks Farm, Little Bursted Farm, Pett Bottom Road CT4 6EG
On the Application Form under section 10 'Vehicle Parking', there is a request for two parking spaces. However, the drawings do not show the locations of the parking allocation. The parish council requests more detail on this request

for Vehicle Parking and asks for clarification if parking allocation would include a request for:

- i. a roadway or track constructed from concrete, stone, tarmac or other material from the entrance/gateway,
- ii. parking bays constructed of concrete, stone, tarmac or other material.

The parish council understands that double gates, being the only access into the field, were installed by a previous owner 'possibly without consent' and an enforcement notice may have been issued for them to be removed. The parish council asks the planning/enforcement officer to investigate this.

#### 8.2 **Footpaths** Rob Veltman, Parish Footpath Warden

On Wednesday 6<sup>th</sup> July I walked many of UH's publicly accessible paths, in the following order: CB378, CB379, Unclassified County Road U11610 (Catt's Wood Lane), CB375 (in part), CB374, CB376 (in part), Permissive Fooptath in Atchester Wood from Lynsore Court, CB380 bridleway (in part), and CB377. These comprise most of the route of the Canterbury Festival Walk from Bossingham Village Hall on 17<sup>th</sup> October. On this occasion, I also walked paths outside the UH parish boundary: HE2 & HE4 (from CB378 to St.Mary's Stelling Church) and HE2 & HE4 from Stelling Farm to CB379, which are also part of the route of the above walk (HE2 & HE4 intersect at the valley bottom).

Note that it is KCC Highways which has the direct responsibility for maintaining U11610, while it is KCC Public Rights of Way (KCC/PRoW), a subdivision of KCC Highways, which has a duty towards the public in respect of paths classified as PRoWs, those paths above prefixed with CB or HE.

The above paths were in good condition, but in places problems have arisen, which I have reported to the appropriate public authority for action:

Unclassified County Road U11610 (Catt's Wood Lane):

- 1. For half a mile of this mile long path from the Bossingham termination, the pathside vegetation is choking the line of the path itself, amounting to an major obstruction
- 2. A notice fixed to a tree by the pathside gate of Little Bossingham farm announced that there is to be a 'non-competitive' motor cycle rally, presumably along U11610, on Sunday 17<sup>th</sup> July. The notice purports to have been issued by a motor sports association in Sidcup & District and claims that the event has agreement of 'the County Rights of Way official maps, Kent County Police and Kent County Council'.

I contacted KCC Highways on 03000 08414141 on the same day as my walk, 6<sup>th</sup> July, and spoke with an official, who noted my observations, giving me a report reference number for each issue: 644490 for 1.(vegetation) and 644492 for 2. (motorbike rally). No apology is given in the bike rally notice; indeed, it doubts 'inconvenience' will be caused, thanking the public for their 'co-operation'. The notice also wrongly assumes that U11610 is a 'Byway'. I communicated this information, with a photo of the notice, to the parish clerk and parish council chair.

My concerns with this announcement are (if it is indeed not a prank): the current condition of U11610 is not suitable for travelling along, whether by bike, motorised or not, or on foot, owing to the overgrowing vegetation. A motorised event along it would inconvenience the public, for instance through the noise it would create and deter the public from their rightful use of the path. It could also result in injury or damage, for which some body or person would bear liability.

CB375 at its termination at The Manor House: Area by roadside stile is clogged with overgrowing vegetation, covering up sight of the PRoW and thus deterring access. Also surface of the path has become waterlogged at this point by a pipe overflow possibly. Request remove vegetation and stem flow of water. I reported this fault to KCC/PRoW. Fault report reference: 220743697.

CB375 in Bursted Wood: Fallen trees near the junction with CB374 causing major obstruction. Fault reported to KCC/PRoW requesting removal of this obstruction. Fault report reference: 220770708.

CB380: Mentioned previously to the PC Chair: The steep, terminating section of this bridleway is still encumbered by thick vegetation obscuring the line of the path.

CB377: The straight line of the path from Mann's Hill to the corner of the Village Hall car aprk on Bossingham Street,

agreed in the County plan in consultation with me, looks as though it is to be revised owing to the location of the current housing development.

Further matters arising from PFW's report to the APM on 17th May 2022:

CB362 Stone Street to Great Catt's Farm, obscuring of entore length of path by crops. Report Ref: 220585038, is now classified by KCC/PRoW as being subject to 'Landowner Action'.

CB376 (south) Because of evidence of knotweed and flytipping at the termination of CB376 on the south side of Mann's Hill, I have, in the absence of an informative response from KCC/PRoW to my email of 1<sup>st</sup> July, consulted a 1987 edition of the County Definitive Map. It clearly shows that when it passes the Scout Hut, the line of CB376 hugs the fence separating it from Stars Meadow.

In addition, it should be noted that the path often taken by local walkers from the gap at the end of the line of CB378 and HE2, in the direction of the Church, along the rear of properties on Bossingham Street to join CB379 & Lime Kiln Road is an *informal* path and not a PRoW. Some action could be taken in concert with the landowner to confirm its 'permissive' status.
